Pursuant to Notification No.35 dated 01.05.2021 passed by the Hon'ble Gauhati High Court and in view of the above circumstances, with a view of the curb the spread of the contagion and taking note of the safety and well being of the Judges, Advocates, and employees working in the establishment of the undersigned, the Hon'ble Gauhati High Court has been pleased to issue the following directions/ guidelines:

1. There shall be restricted court functioning with "staggered Roster" in all the courts, so as to maintain social distancing.
2. All court shall function in **Virtual mode**.
3. The following category of cases shall be taken up :
 - i. Bail matters,
 - ii. Remand matters,
 - iii. Recording of statement of accused persons under section 313 Cr.P.C. by invoking sub-section (5) of section 313 Cr.P.C.,
 - iv. Injunctions matters,
 - v. Cases pending for final arguments,
 - vi. Petitions seeking interim maintenance,
 - vii. Zimma petitions,
 - viii. Recording of statement under section 164 Cr.P.C.
 - ix. Issuance of Cheque to the claimants in MAC cases,
 - x. Rent Deposit cases,
 - xi. Any other matter, which is deemed to be utmost important and urgency.

(Remand matters and recording of statements under section 164 Cr.P.C. shall be taken up by the concern magistrates, who shall ensure physical production of the accused/ Victims by observing strict covid 19 protocols)

For filling of the abovementioned cases, the learned Advocate may file the said matter(s) alongwith scanning of all documents through below mentioned email.
