Applications are invited from eligible candidates for 1 (One) unreserved Grade-IV post of **ATTACHED PEON** in the establishment of the undersigned in the Pay Scale of PB-1 - (Rs. 12000- 52000) + GP- Rs. 3900+ other allowances as admissible as per govt. rules.

ELIGIBILITY :-

- 1) The candidates must be Indian Citizens.
- 2) The candidates must read upto Class-Eight.
- 3) The candidates must not be less than 18 years and more than 43 years of age as on the date of application. Relaxation of age will however be given as per Govt. Rule

 - (c) Self-attested ccopies of testimonials in support of his/her AGE, CASTE, EDUCATIONAL QUALIFICATION & EXPERIENCE.
- 2) Candidates already in govt. service must apply through proper channel.

The candidates will have to appear an Interview (Viva-Voce) carrying 30 marks at their own expenses. The selection will be made purely on merit basis. 
