**Eligibility :**

**For Post. No.1 & 2:-**

The candidates must be Indian Citizens and must possess the **minimum educational qualification of Class-VIII standard and those who have passed HSSLC or above shall be ineligible.** The candidates must not be less than 18 years and more than 40 years of age as on 01.01.2023. However relaxation for upper age limit for SC/ST is upto 45 years, OBC/MOBC is 43 years, for Ex-servicemen 42 years and up to 50 years for persons with Disabilities as per Assam Govt. Rule OM. No. ABP.6/2016/51 Dated 2.09.2020.



## **HOW TO APPLY :-**

**For post No. 1 & 2 :-** Eligible candidates will have to apply in Standard Form of Application (published in the Gazette Part IX of Govt. of Assam). **The candidates shall clearly mention his preference for the post on top of the application. Further one application for both the post will suffice. The candidate need not submit two separate application forms.**

The candidate must submit the application to **"The District & Sessions Judge, Karbi Anglong, Agriculture Colony, Diphu, Karbi Anglong- 782460"**.

1) The application must be accompanied with the following: -

- a) Two recent colour-passport size photograph,
- b) Self-attested copies of testimonials in support of his/her AGE, CASTE, EDUCATIONAL QUALIFICATION & EXPERIENCE.
- c) Mobile Nos. written on the top of the Standard Form in RED INK.

2) Candidates already in govt. service must apply through proper channel.

**Conditions:**

For Post No. 1 & 2:

The candidates must be Indian Citizens and must possess the minimum educational qualification of Class VIII (8th) and above who have passed SSLC or above shall be eligible. The candidates must not be more than 40 years of age as on 01.11.2014 provided that the upper age limit for SC/ST is 45 years, OBC/UR is 43 years. The minimum age is 18 years and up to 30 years for persons with disabilities as per Rules 57C, 57D and 57E of the Indian Constitution.
