Eligibility :

1. For Post. No.1 & 2:- The candidates must be Upper Division Assistant of the District & Sessions Judge Establishment (Ministerial) concerned on the basis of seniority cum merit who have rendered not less than 7 years of service in the District & Sessions Judge Establishment (Ministerial) concerned out of which at least 3 years shall be of continuous service as Upper Division Assistant as on 01/01/2022.

2. For Post. No.3 :- The candidates must be Indian Citizens and must be class VIII passed. The candidates must not be less than 18 years and more than 44 years of age as on the date of application. Relaxation of age will however be given as per Govt. Rule.

HOW TO APPLY :-

For post No.1 & 2:- Intending candidates shall submit their applications in Standard Form of Application (published in the Gazette Part IX of Govt. of Assam) through proper channel to "**The District & Sessions Judge, Karbi Anglong, Agriculture Colony, Diphu-782460**" either through personally or through post. The Applications must be with accompanied with- (i) Two recent coloured passport size photographs (ii) Experience Certificated issued by the respective District & Sessions Judge (iii) All testimonials in support of their educational qualification, experience and cast and (iv) Copy of Service Book. The last date of receipt of duly filled up applications is **19/10/2022** by 5 PM.

For post No. 3:- Eligible candidates will have to apply in Standard Form of Application (published in the Gazette Part IX of Govt. of Assam) and must submit to "**The District & Sessions Judge, Karbi Anglong, Agriculture Colony, Diphu, Karbi Anglong- 782460**". Last date of receipt of application is **19/10/2022** till 5.00 PM.

- 1) The application must be accompanied with the following: -
 - a) Two recent colour-passport size photograph with name on reverse side,
 - b) One Self-addressed Envelope affixing postage stamp of Rs. 5 thereon,
 - c) Self-attested copies of testimonials in support of his/her AGE, CASTE, EDUCATIONAL QUALIFICATION & EXPERIENCE.
 - d) Mobile Nos. written on the top of the Standard Form in RED INK.
- 2) Candidates already in govt. service must apply through proper channel.

SELECTION PROCEDURE: -

The candidates for the posts will have to appear an Interview (Viva-Voce) at their own expense. The selection will be made purely on merit basis. Canvassing directly or indirectly by any candidate will lead to cancellation of his/her candidature. The appointing authority reserves the right to reject over-qualified candidates i.e. graduate or postgraduate for the post No. 3 i.e. for the post of peons.

The selection will be made purely on seniority cum merit basis for the post No. 1 & 2 and for the post of peons selection will be made purely on merit basis.
