

The quotations will be opened on 15-05-2019 at 2.00 p.m. The bidders or their representatives, not more than one for each quotation, may be present, if they so desired, at the time of opening of Quotations.

3. The Auction of the said seized vehicles will be governed by the following conditions:-

- i. The vehicles will be auctioned separately for each vehicle, not through the lot.
- ii. The vehicles will be sold on "**As is where is basis**".
- iii. The successful bidder will be required to deposit the bid amount in cash within 7 (seven) working days of the acceptance of bid.
- iv. The delivery of the auctioned vehicles will be arranged only after making the payment in cash and after submission of documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms).

- v. The auctioned vehicles will be removed by the successful bidder within 02 (two) working days of depositing the bid amount, at their own expenses.
- vi. The vehicles will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Office.
