NOTIFICATION
07.01.2022.

Pursuant to Notification No.03 dated 06.01.2022 passed by the Hon'ble Gauhati High Court and in view of the recent surge of the COVID-19 cases in the state of Assam and in order to ensure preventive course within the premises of the establishment of undersigned, has been pleased to notify the following rules with effect from 07.01.2022.

1. Cases may be heard in virtual / hybrid mode as per the convenience of the concerned Presiding Officer.
2. Time slots may be fixed by the concerned Presiding Officer for taking up cases in order to avoid overcrowding in the Court premises.
3. All the UTPs may be produced through video conferencing except first production and recording of statement u/s 164 of the Cr.P.C.
4. The pending cases against MPs / MLAs may be taken up through video conferencing as far as practicable.
5. The evidence of M.O. / I.O. may be recorded through video conferencing.
6. Entry inside the Court premises shall be restricted. Only lawyers / litigants whose presence is necessary and Court staff shall be permitted to enter the Court premises on production of final COVID vaccination certificate.
7. Non-vaccinated / partially vaccinated lawyers / litigants / Court staff shall be permitted to enter the Court premises only after the production of a negative RT-PCR test report not older than 48 hours.
8. Wearing of face masks and maintaining social distancing shall be mandatory.
9. A register shall be maintained in the entry point recording the name, address and phone number of every outsider entering the Court premises.
10. Canteen inside the Court premises shall operate in a restricted mode with only take away facility.
11. The learned Advocate(s) may contact the following Nodal Officers for filling of cases involving urgency. The time of filling of cases involving urgency shall be **between 10:00 am to 01:00 pm** on every working day.
